## The Year(s) in Review

The Community Justice Center is an innovative legal services non-profit based in Trenton, serving the low-income/homeless disabled, disabled veterans and their families, primarily within Central New Jersey. We opened our doors in March 2009, representing clients before both the Department of Veterans Affairs and the Social Security Administration. Staff has worked extensively with those battling mental illness and other more “invisible” impairments, including traumatic brain injury (TBI), post traumatic stress disorder (PTSD), and spectrum disorders, and has been trained in trauma awareness, (il)literacy awareness/dyslexia, and other circumstances and conditions common to many of our clients.



The past two years have been chock full of exciting opportunities and milestones, many of which are detailed inside these pages. We welcomed our **650<sup>th</sup> client**, increased our visibility and voice throughout Central New Jersey, and thanks to the generous support of **BCB Community Bank of Monroe Township**, hosted **TAPPED 2016** in support of our services. We were especially humbled by some of our former clients having chosen to “pay it forward” and speak at the event!

Thanks to the continued support of **The Harbourton Foundation**, we have been able to solidify our presence in Hunterdon and Middlesex Counties, while maintaining a high level of service in Mercer County. Amid great success in 2014-2015, we were again selected to receive funding from Hunterdon County for 2016-2017, under its *Human Services Community Programs*, and are hopeful to be awarded funding for the next cycle as well. We are thrilled to continue our relationship with the Hunterdon County Department of Human Services’ Division of Senior, Disabilities & Veterans Services. In Middlesex County, our collaborative effort with Elijah’s Promise remains strong – our achievements over the years have led to eligibility for the Middlesex County 2018 Freeholder Support Grant for the first time. We’re in the running for our program ***Making the Invisible Visible: Reclaiming Voices and Restoring Hope***, so keep your fingers crossed for us! Turn the page to discover more about our efforts in Middlesex County, along with the expansion of services into Somerset County.

In Fall 2017, we were again honored in and by our own backyard, as we were selected by the **I Am Trenton Community Foundation** to be part of its growing family of change agents in Trenton. Our grant will assist those most financially impoverished and struggling with “invisible” illnesses – many of whom have been driven underground and into silence or worse, suicide – by empowering them to reclaim their voice and restore the hope necessary to continue fighting for their own lives. I also had the privilege of speaking before the New Jersey Advisory Council on Traumatic Brain Injury, following the publication of my story *Racing the Sunset* in a special edition of **Chicken Soup for the Soul: Recovering from Traumatic Brain Injuries**. The book endeavors to connect civilian and military survivors, while simultaneously providing support for non-profits working in the field. It’s a win-win for everyone, especially for survivors like myself, who feel like their voices are being heard and validated, and that their invisible wounds are a bit less invisible now.

Of all the events and opportunities these past two years, most moving and impactful was **BASETRACK Live**. Sometimes our work takes its toll, and participation in events like these reinvigorates and recharges us. We were psyched that the traveling performance made a stop at William Patterson University in Fall 2016, and we had the opportunity to attend! BASETRACK Live is a powerful combination of live music, imagery, and post-deployment interviews, interwoven to expose the all too common struggles following deployment and reintegration, especially when coupled with newfound medical issues. Their own words could not describe them better: “BASETRACK Live is a multimedia documentary theatre piece about the life-altering impact of war on veterans and their families – a complicated and sensitive portrayal of how war affects us all. Two actors play AJ and Melissa Czubai, a real life young Marine and his wife. We follow their journey from his deployment to Afghanistan through his return home, while hearing and seeing the harrowing stories of others who served with him in Marine Corps Unit One-Eight.” Turn the page to learn more.

# We're Expanding into Somerset County!

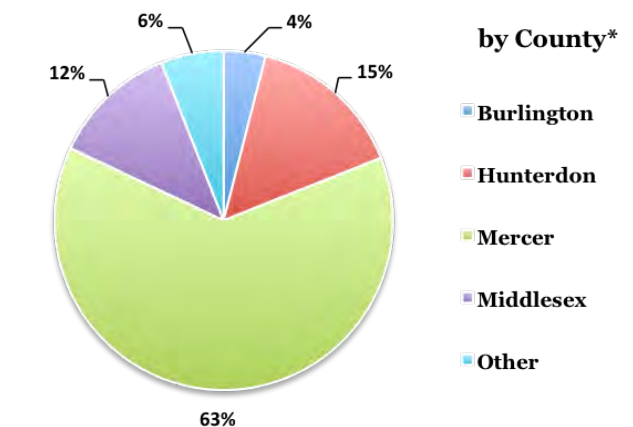
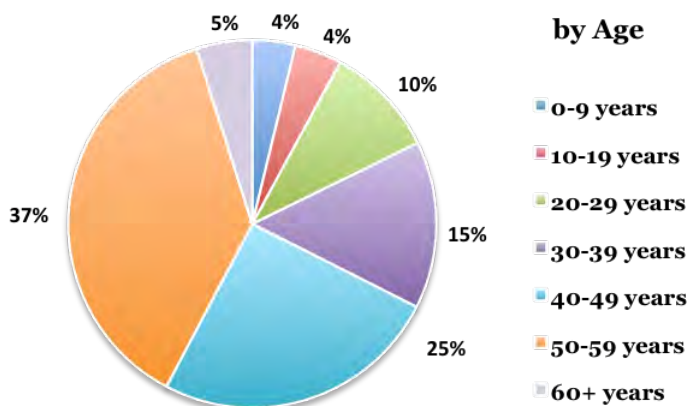
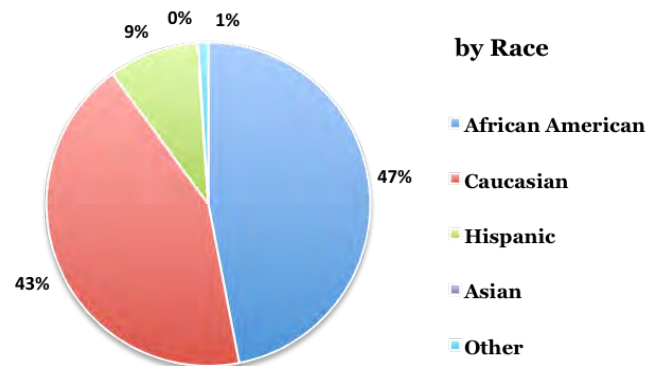
Since 2011, the Community Justice Center and Elijah's Promise, a multiservice resource center in New Brunswick, have had a fantastic ongoing collaboration. Our emphasis on empowering vulnerable populations complements the mission of Elijah's Promise: to Empower Lives, Invite Justice, and Alleviate Hunger. Thanks to their generosity, their facility serves as the hub for our presence in Middlesex County, allowing Community Justice Center staff and case managers from some of our partnering organizations, including Rutgers University Behavioral Health Care, to meet with prospective clients.

In Fall 2017, we expanded our services into Somerset County! Using a model proven successful for years in Hunterdon County, Somerset County's Department of Human Services, Office on Aging and Disability Services will now host office hours for Community Justice Center staff to meet with clients on site. By bringing services to their home county, we are opening doors for many Somerset County residents who lack transportation or ability to travel to Flemington (Hunterdon) or New Brunswick (Middlesex). I look forward to pursuing new opportunities for outreach throughout Somerset County and surrounding areas. ## Any Way You Slice It, We're Reaching the Community

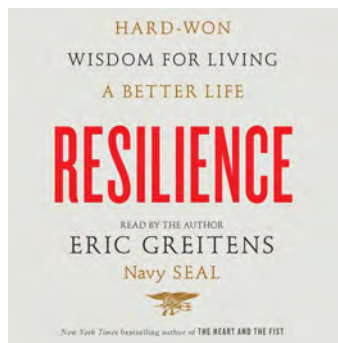
The Community Justice Center assists the low-income disabled (that is, 175% of the poverty level or below), with an emphasis on veterans, the homeless, and those struggling with "invisible" illnesses – in short, those who tend to fall through the cracks most frequently. In addition to full representation and brief service, the Community Justice Center provides training and information sessions upon request to area agencies, government units, and consumer-run support groups.

Throughout 2016 and 2017, demand for services remained consistently high. The Community Justice Center provided full representation to **265 clients**, during which time 86 cases were opened, and 123 were closed. Represented below is the demographic spectrum of the 265 clients for which it provided full-representation in both years.



\* Other includes Atlantic, Camden, Essex, Hudson, Ocean, Somerset & Union Counties.

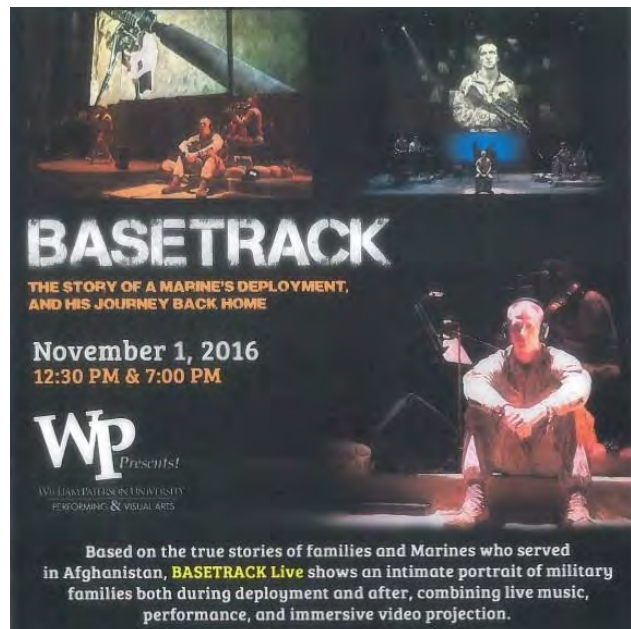
\* Please note that roughly half of CJC's clients are homeless—they have been included in the county in which they receive emergency services.
